







Examination Fee Guidelines:

- After successful payment of the examination fee, students must submit a copy of the payment receipt at the **Examination Branch counter**.
- Fee Payment Requirements:** The examination fee portal will **not accept** payments unless all **college fee dues** are cleared.
- Strict Deadline:** Students are **required to pay** the examination fee **before the last date**. Late payments will not be accepted.
- One Submission Only:** **Multiple submissions** of the examination fee receipt will **not** be accepted. Only one submission per student is allowed.
- Confirmation of Payment:** If the fee amount is debited from your account, wait for the **confirmation message** from the bank. Check your **online bank statement** after a few hours to confirm the payment status.
- Unsuccessful Payment:** If, after **24 hours**, the transaction is not successful, and the amount is **still not debited** from your account, please inform the **Examination Branch** and attempt to pay the fee again.
- Multiple Transactions:** If the amount is debited multiple times for the same payment, report the issue to the **Examination Branch** immediately, providing **all payment receipts** for verification.
- A fee of ₹250/- towards the *maintenance and preservation of tabulation records* is to be collected as per Osmania University Letter No. 380/Acad-I/2025, dated 11-04-2025.
